In accordance with DOD Directive 5230.9, Clearance of DOD Information for Public Release, and the Joint Ethics Regulation (DOD 5500.7-R), personal blogs or web-logs may not contain non-public information on military activities of the command, to include activities related to training and preparation for the Naval Special Warfare/Naval Special Operations (NSW/NSO) community. This prohibition extends to Internet postings on social networking sites, including, but not limited to: Facebook, Instagram, and Twitter.


Furthermore, you will not: (1) agree to interview or plan any media event and (2) make statements to media regarding participation, intentions, contract or approval to the NSW/NSO community. Any media inquiries will be immediately forwarded to your recruiter or the Recruiting District Public Affairs Officer.

A clandestine Warrior operates in a world of obscurity; strict adherence to this agreement is demanded for your security and safety of your family and teammates. The command recognizes that applicants, prospects, and Future Sailors, are proud of their accomplishments and desire to share information about NSW/NSO training with family and friends. You may discuss with your friends or family regarding your intentions to join the US Navy and participate in the NSW/NSO program. However, applicants, prospects, and Future Sailors should explain operational security concerns to loved ones and should endeavor to influence the Internet usage habits of family and friends to correspond to this guidance and not post non-public information on military activities.

“Non-public information on military activities” includes, but is not limited to, comments on daily military activities and operations (including training evolutions), unit morale, and other information that may be beneficial to adversaries. “Personal blogs or web-logs” are those not having official DOD sponsorship and purpose.

I certify that I have been informed of the requirements of DOD Directive 5230.9, Clearance of DOD Information for Public Release, and DOD 5500.7-R, Joint Ethics Regulation, and understand the directives contained therein. I further understand that a copy of these regulations will be made available for my review at my request.

I hereby acknowledge the above NAVPERS 1070/613 entry. Violation of this order could result in your disenrollment from the NSW/NSO program and potentially prevent your enlistment into the United States Navy.
